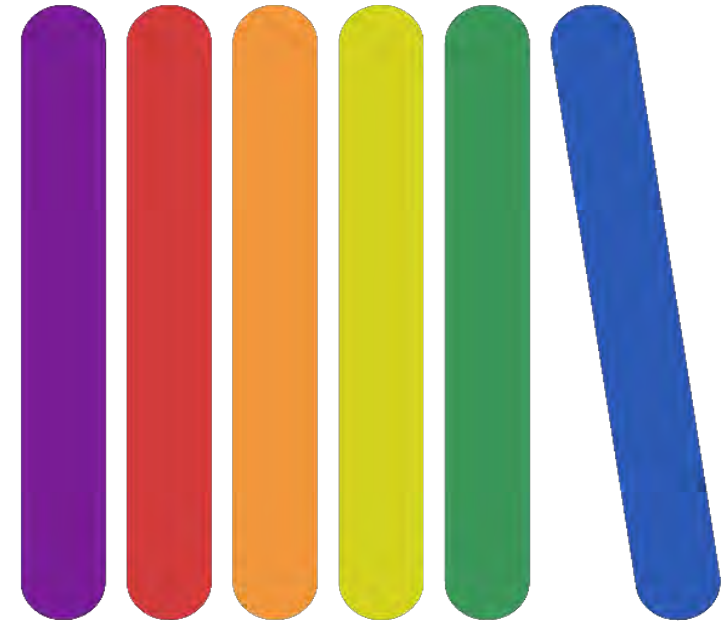

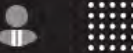
# Consignment Tracking Software

## New Tracking Software

- Integrate with TRACES to alert PH Officers with incoming consignments
- Use check rules to determine which consignments require document/physical checks
- Assign inspectors
- Take payments from agents
- Create database of agents and importers
- Flag at risk consignments to prioritise workloads
